Sub: Deterioration in Air Quality in Delhi –NCR- steps to be taken –reg.

Please refer to the above subject and cited reference through which the Central Pollution Control Board (CPCB) has directed the State of Haryana to implement the various directions of Graded Response Action Plan (GRAP) notified by the Central Government. The copy of the communication has been enclosed along for reference.

Accordingly, the following actions are to be ensured by the implemented agencies in all NCR Districts of Haryana.

- a) Hot mix plants and stone crushers shall remain closed all the time till January 20, 2021.
- b) Frequency of mechanized cleaning of roads and water sprinkling to be increased particularly on the road stretches with high dust generation potential.
- c) It shall be ensured that guidelines / standard operating procedures for dust mitigation at construction sites are strictly adhered to. In case of violations, strict action should be taken against the violators like imposition of penalty temporary stoppage of construction activities.
- d) Agencies must ensure that there are no incidences of open burning of wood / garbage / biomass / industrial waste. In case of violations, penalty should be imposed in accordance to law.

The above directions of CPCB may be taken up on **Top Priority**, and action taken in this regard be sent to the Board for compilation and submission to CPCB.
