Minutes of 4<sup>th</sup> meeting of State Level Committee constituted in compliance order dated 16.01.2019 of the Hon'ble NGT in OA No. 606 of 2018 held under the chairmanship of Justice Pritam Pal, Former Judge of Punjab and Haryana High Court, at 0930 Hrs on 14.05.2019.

4<sup>th</sup> Meeting of State Level Committee, constituted in compliance of directions of Hon'ble NGT issued on 16.01.2019, in OA No.606/2018 in the matter of 'Compliance of Solid Waste Management Rules, 2016', was held under the chairmanship of Justice Pritam Pal, Former Judge of Punjab and Haryana High Court, on 14.05.2019 in Conference room of Directorate of Urban Local Bodies, Sector-4, Panchkula, to review the status and progress of implementation of Solid Waste Management Rules, 2016 in the State of Haryana. The list of participants is as per **Annexure-1**.

At the outset, Member Secretary, HSPCB cum Member Secretary of SLC welcomed the chairperson and members of the State Level Committee and briefly explained the important agenda points for discussion. The important points discussed and the decisions taken during the meeting are as below.

- 1. The minutes of the previous meeting were confirmed.
- 2. As a part of review of Action Taken Report on the decisions taken in the earlier meetings, Director ULBD briefed the Committee Members about the progress made on Solid Waste Management, Plastic Waste Management, and C&D Waste Management by every ULB in the State. The committee was also apprised that ULBD is collecting district wise monthly progress report as per the Performa prescribed by Hon'ble NGT covering the key waste management performance indicators/parameters from all the districts and the same is being compiled for submitting the status report in Hon'ble NGT.
- 3. Reviewed of Status of Management of Solid Waste in Gurugram -Faridabad cluster and Sonepat- Panipat cluster.

### i) Faridabad:

The Commissioner, Municipal Corporation, Faridabad (MCF) apprised as under:

a) MCF has identified 617 Bulk Waste Generators (BWG) and 24 of these BWGs are doing on-site composting.

- b) 533 Challans have been issued by MCF against different violations of SWM Rules 2016.
- c) Door to door collection has been started in all the 40 wards and 90.87% households have already been covered.
- d) Transportation vehicles have been provided with compartments and GPS system.
- e) 7 Material Recovery Facilities have been set up in the Cluster for segregation and transportation of waste to the dump site.
- f) Processing of Wet Waste: -
- g) As per MoU signed between MCF, Indian Oil Corporation and M/s Eco Green, another plant of capacity of 5 TPD has been installed by Indian Oil Corporation in Sector-13 Faridabad which has been made functional. 3 shredding machines have been installed by MCF for disposal of horticulture/green waste. Pit composting/natural composting is being done by MCF in 30 public parks. Presently, 2625 Kg of wet garbage is being processed every day.
- h) One common site for MCF and MCG of legacy waste is situated at Bandhwari. As informed by MCG, a RFP for disposal of legacy waste at Bandhwari plant has already been floated by M/s Eco Green. Besides, one Ballistic separator machine has been installed at Bandhwari site by M/s. ECO-Green for disposal of legacy waste.
- Notification for C & D waste has already been issued in the newspapers. A survey is being conducted by the MCF to assess the quantity of C&D waste.
- j) Three sites have already been identified for storage/ processing of C &D waste by MCF and permission to float EOI for installation of plant is being taken from Election Commission through Screening Committee constituted by Chief Secretary of Haryana.
- k) Mandatory use of plastic waste in road construction is under process.
- MCF has established 2 Nos. Plastic banks to store the polythene carry bags, plastic bottles etc.

m) 186 Challans have been issued by MCF and recovered composition fees of Rs. 514500/- from 01.01.2019 to 10.05.2019. 94.400 Kg polythene was also seized by MCF.

#### ii) Gurugram:

The Commissioner, Municipal Corporation Gurugram cluster apprised the status of the work as below.

- a) MCG has identified site for setting up of MRF and is working with EPR partners to setup system for plastic waste management by first week of August 2019.
- b) For plastic waste to be used in road construction, MOU has been signed with KK plastic for collection, segregation, cleaning and shredding.
  Collection centre is under construction at Begampur khatola industrial area.
- c) 2 Bio-Gas plants of total capacity 70 MT/day are under process. 20 MT Bio Gas Plant at Dhanwapur STP Gurugram will be functional by December 2019. 50 tons per day Bio-methanation (organic waste to Biogas) Plant in the premise of Dhanwapur STP, under CSR initiatives through IOCL will be functional by end of March 2020.
- d) MCG is in the process of engaging the Mobile Composting Units (Mobi-Trash) in those wards where space for setting up composting plant is a major constraint.
- e) Total 5136 challans are generated against various solid waste management rules in a period of 9 months.
- f) For Leachate treatment at Bhandwari, a leachate treatment plant of capacity 150 KLD, a ballistic separator & a pilot leachate treatment plant of 24 KLD on MVR based technology has been set up.
- g) MCG in coordination with Feeding India and Robin Hood Army are in process to setup Food ATM.
- h) 29512.560 MT of C&D waste has been transported by the concessionaire to Basai plant. To redress the complaints related to C&D waste in city,

MCG has constituted team for picking up of C&D waste from door to door. Till date MCG has collected 46230 MT of C&D waste against all complaints received.

- i) For non compliance of rules; a penalty of Rs. 5,000/- for non disclosure of generation of C&D waste. 49 Challans against illegal dumping of C&D waste and 61 challans of Principal Generators have been done during special drive from 5.4.2019 to till date.
- 4. Further Member Secretary, HSPCB informed that the prevailing tanker system adopted for collection and transportation of domestic effluent and treatment of the same in STPs in Gurugram, Faridabad, Sonepat and other few places is not a scientific method for disposal as per the norms and must be treated as temporary provision in case of exigencies only. Further, he also advised that sewerage lines must be laid for feeding the waste water to STPs. The progress must be reviewed in this regard in every meeting.

After detailed deliberations, the following decisions were taken.

 ULBD, GMDA and TCP shall provide their inputs regarding number of such units being operated currently and timeline for completing the task in the next meeting.

#### (Action by : ULBD, GMDA, TCP and HSPCB)

ii) Visit by Municipal Commissioners and concerned officers of respective ULBs must be made to the STPs in their jurisdiction atleast once in a month for monitoring the functioning of STPs. The review of the STPs and progress made under shall be kept as agenda point from the next meeting onwards. ULBD shall compile the progress in this regard for the previous month and submit the same to the Committee.

### (Action by : ULBD)

 iii) Progress made in the compliance of SWM Rules 2016 in 7 model cities notified by ULBD and the Panchayats, notified by Panchayat Department, shall be reviewed by the Committee in every meeting. ULBD and Panchayat Department shall submit the progress made during the month and the target for the next month in this regard.

#### (Action by : ULBD and Panchayat Department)

iv) Issues pertaining to Bahadurgarh dump-site were discussed in the meeting. MS, HSPCB informed that EPCA Chairman (Dr Bhurelal) has reported the issue relating to solid waste dumping in many areas of Bahadurgarh in many instances and the same has been brought to the notice of Deputy Commissioner, officers of MC and Department of Industries. It was also conveyed to the Committee that EPCA is not satisfied with the progress made in this effort and EPCA has also mentioned the incidents of frequent burning of solid waste in certain specific pockets of the town.

The Committee decided that an action taken report in this regard must be presented in the next meeting of the SLC, along with the action plan with specific time lines. A surprise visit may also be made by senior officers of ULBD in this regard to MC Bahadurgarh.

### (Action by : ULBD, Industries Dept and DC, Jhajjar)

- v) The Director ULBD assured that all the requisite efforts shall be made and vigorous monitoring will be done to comply with the waste management rules and NGT orders in a time bound manner. The Committee further directed as under:
  - a) The Commissioners of the seven model towns namely MC Faridabad, MC Gurugram, MC Panipat, MC Panchkula, MC Fatehabad, MC Thanesar & MC Jind shall attend the SLC meetings from now onwards.
  - b) Surprise visits be conducted in ULBs to check the actual work position.
  - c) Interactive sessions may be conducted so that community participation can be accelerated.
  - d) Universities, Boarding schools, Communities, Hospitals and such Bulk Waste Generators must be treated on priority.

e) It was also decided to visit the Bandwari plant and to hold a meeting with MC Gurugram & MC Faridabad and ULBD by the committee members for which necessary arrangements may be made after consulting the Chairman's office.
