### **Kind Attention**

### Regulations for use of DG sets in NCR districts of Haryana.

The Commission for Air Quality Management in NCR and Adjoining Areas (CAQM) issued Direction no. 73 regarding regulations for use of DG sets in the NCR.

The CAQM directed that new regulations of DG sets would come into force in the entire NCR strictly w.e.f. 01.10.2023 and retro-fitment of dual fuel kits or ECDs, wherever warranted, must be targeted to be completed latest by 30.09.2023, failing which the use of the diesel gen sets shall not be permitted under any circumstances, anywhere in the entire NCR.

Earlier DG sets were permitted for essential services (even without any emission control and pollution abatement measures) during period of restriction under the GRAP. Hospitals, residential/ office complexes, commercial entities etc., therefore, need to pay particular attention to the matter.

The above mentioned directions envisage the following compliances:-

In view of the above, all stakeholder using DG sets in the NCR have to comply with the above said Direction of CAQM well before 30.09.2023, failing which action will be taken as per law.
