## Notice for Restaurants/Dhabas/Motels/Marriage Halls/Banquet Halls/Party Lawns, Compressed Biogas (CBG) / Bio-CNG plants and Footwear industry

This is for the information of project proponents of all the industrial sectors/non industrial sectors /units falling under Red, Orange and Green Categories of consent management of the Board as per order of categorization issued vide Endst. No. HSPCB/PLG/PLG-135/2016/546-572 dated 14.07.2016, order Endst. No. HSPCB/2018/517-546 dated 26.02.2018 (as amended) and subsequent Order No HSPCB/PLG/2020/ 1767-1795 dated 04.12.2020. The industrial sectors/non industrial sectors /units falling under Red, Orange and Green Categories of consent management of the Board are required to apply to this Board for obtaining Consent To Establish (CTE) and Consent To Operate (CTO) under Water (Prevention and Control of Pollution) Act, 1974 Air (Prevention and Control of Pollution) Act. 1981 and for and authorizations/registrations under various Waste Management Rules under Environment (Protection) Rules, 1986 through online portal of Haryana Enterprises Promotion Centre (HEPC).

The Board vide office order Endst. HSPCB/PLG/2021/2210-2268 dated 13.09.2021 has covered Restaurants/Dhabas/Motels/Marriage Halls/Banquet Halls/Party Lawns under Red, Orange and Green category of the consent management of this board. Accordingly a public notice was published in the leading newspapers on 11.11.2021 for the information of concerned stakeholders. It has been informed that concerned stake holders to visit the website of this board for checking about coverage of their industrial sectors/non industrial sectors /units under consent management of board and follow the provisions of consent procedure issued by the Board for obtaining the necessary consent and authorizations under relevant rules/acts following due procedure.

The Board vide office order Endst. HSPCB/PLG/I/108468/2022 dated 18.04.2022 has revised and added category of 'Compressed Biogas (CBG) / Bio-CNG plants' and 'Household bio-digesters/gobar-gas (cow-dung) plants based on biodegradable waste etc. under the respective category of Red, Orange and Green. The category of 'Footwear other than leather footwear (excluding stitching of upper part)' was also added under Orange category of consent management of the Board,

It has been observed that a number of Industrial/ Non-Industrial Sectors/Projects covered under the consent management of this Board vide order dated 13.09.2021 and 18.04.2022 have not applied for obtaining mandatory consent from the Board.

In view of above, all the concerned stake holders are hereby informed through this public notice to obtain necessary consent and authorizations under relevant rules/acts following due procedure within a period of 30 days of publishing of this notice. Any non-compliance/violation in respect of above attracts action including penal actions as per provisions of applicable Act/ Rule/Policy.
