Office Order

The agenda regarding grant of consent to establish / consent to operate to units located in Non-conforming area was placed before the Board in its 165th meeting held on 30.8.2012 vide agenda item No. 165.8 (S) and the Board has approved the proposal that the Pollution Control Board will not ask for CLU from existing units which were operating before 1.4.2011 in non conforming area as the HSPCB is to deal with these cases only from pollution angle and will give provisional consent to operate on year to year basis till CLU is obtained provided they are having adequate pollution control devices. However, these units will be required to obtain Ex-post facto Consent to establish within a period of 6 months and shall also obtain consent to operate within this period. No action will be initiated against these units within period of 6 months because Consent to establish /Consent to operate could not be issued earlier to these units for want of CLU earlier. if these units failed to install requisite pollution control devices and failed to obtain ex-post facto consent to establish and consent to operate within specified period action shall be taken against these units under the provisions of Water/Air Acts. Further, no permission shall be given to the units located in Municipal areas, HUDA areas, TP schemes of the Committee or any other approved residential colony/ Area.

This policy will be applicable only for Orange category of industries.

All the concerned shall ensure the compliance of the above said decision of the Board, effectively.

Whereas the Board had laid down the procedure to grant the Ex-Post Facto Consent to Establish and Consent to Operate for the units/projects existing and operating since before 01.04.2011 in non confirming areas vide Head Office order Endst. No. HSPCB/PLG/2012/2977-96 dt. 16.11.2012 for orange category of industries/projects which was applicable for 06 months only.

Whereas the TAC (Policy) in its meeting held on 12.02.2014 examined the matter and recommended that the above policy approved by the Board in its 165th meeting held on 30.08.2012 vide resolution No. 165.8 (S) and circulated vide Head Office order Endst. No. HSPCB/PLG/2012/2977-96 dt. 16.11.2012 may be extended further for a period upto 31.03.2015 and may be made applicable to all categories of industries/projects covered under Consent management, operating in non confirming areas since before 01.04.2012 and having installed adequate pollution Control devices to meet all the applicable standards prescribed under Environment (Protection) Rules, 1986 with a provision that no permission shall be given to the units/projects located in Municipal areas, HUDA areas, TP scheme of the Committee or any other approved residential colony / area as already approved by the Board.

Whereas the Board in its 170th meeting held on 18.02.2014 approved the recommendations of the TAC (Policy).

Therefore in view of above, the policy circulated earlier vide Head Office order Endst. No. HSPCB/PLG/2012/2977-96 dt. 16.11.2012 will be applicable with the above said amendments for all categories of industries/projects covered under consent management upto 31.03.2015.

All the concerned shall ensure the compliance of the above said decision of the Board effectively.
