Office Order

Whereas, the Board has already prescribed the performance security to be charged from industrial sectors/project proponents covered under Red and Orange category for obtaining consent to establish (CTE) under Water Act, 1974 and Air Act, 1981 vide order dated 06.03.2017 published on 15.04.2014 in Haryana Government Gazette. Similarly the performance security to be charged from the units/projects, for suspension of closure orders and for grant of time to the units to makeup the deficiencies/inadequacies, has also been prescribed for red and orange category of industrial sectors/projects vide order Endst. No. HSPCB/PLG/2012/2957-76 dated 16.11.2012;

Whereas, the Board has now re-categorized the industrial sectors/projects for the purpose of consent management under Red, Orange, Green and White categories based upon their pollution potential as per CPCB directions dated 07.03.2016 but White category of industrial sectors/projects has been exempted from consent management. In view of above recategorization of industries and inclusion of green category projects under consent management, it has become necessary to prescribe schedule of performance security to be charged from Green category of industrial sectors/projects for obtaining CTE as well as for suspension of closure orders and for grant of time to the units to makeup the deficiencies/ inadequacies:

Whereas, the matter was placed before the Technical Advisory Committee (TAC) of the Board in its meeting held on 20.04.2017 and it has been recommended by the TAC that the amount of performance security being charged from the red and orange category of industrial sectors/projects may be kept same as already prescribed vide order Endst. No. HSPCB/PLG/2012/2957-76 dated 16.11.2012 and in case of green category of industrial sectors/projects, the amount of performance security may be charged as per Annexure-A, for the purpose of obtaining consent to establish under Water Act, 1974 and Air Act, 1981, for suspension of closure orders under various Acts, for grant of time to the units to makeup the deficiencies/inadequacies in pollution control measures and for compliance of shortcomings of refusal of consent to operate. No performance security may be charged from white category of industrial sectors/projects;

Whereas the above mentioned recommendation of the TAC has been accepted and approved.

In view of above, it is a hereby ordered that the amount of performance security prescribed as per Annexure-A, shall be charged from Green Category of industrial sectors/projects for the purpose of obtaining consent to establish under Water Act, 1974 and Air Act, 1981, for suspension of closure orders under various Acts, for grant of time to the units to makeup the deficiencies/inadequacies in pollution control measures and compliance of shortcomings of refusal of consent to operate. No performance security will be charged from white category of industrial sectors/projects.

These orders shall come in to force with immediate effect.
