Office Order

Whereas the Board vide Head Office order endst. No. HSPCB/PLG-142/2016/6204-6227 dated 22.03.2016 and order endst. No. HSPCB/PLG-142/2016/6228-6251 dated 22.03.2016 has laid down the procedure for auto renewal of consent to establish (CTE) and consent to operate (CTO) respectively under Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981 in partial modification of the consent policy issued vide Endst. No. 10195-10218 dated 07.03.2014, in view of Haryana Enterprises Promotion Policy, 2015 issued by Haryana Government, Industries & Commerce Department notified on 1st October 2015;

Whereas the Board in its 175th meeting held on 04.05.2016, vide resolution no. 175.7 has accorded Ex-Post Facto approval of the above said procedure laid down for auto renewal of consent to establish and consent to operate under Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981.

Whereas Board has issued order regarding re-categorization of industrial sectors under Red, Orange, Green and White categories vide order endst no. HSPCB/PLG/135/2016/546-572 dated 14.07.2016 in view of modified directions issued by CPCB vide letter dated 07.03.2016 wherein the Green category of industries/projects has also been covered under consent management, apart from Red and Orange category of industries/projects and white category of industries have been exempted from consent management and therefore there is need to include the green category of industries/projects in the ambit of procedure already laid down by the Board for auto renewal of CTE and CTO under Water Act, 1974, Air Act, 1981 vide orders referred above.

In view of above, it is hereby ordered that the procedure already issued vide Head Office order endst. No. HSPCB/PLG-142/2016/6204-6227 dated 22.03.2016 and order endst. No. HSPCB/PLG-142/2016/6228-6251 dated 22.03.2016 for auto renewal of consent to establish (CTE) and consent to operate (CTO) respectively under Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981 for Red and Orange category of industries/projects shall also be applicable and followed for the cases of Green category of industries/projects for auto renewal of CTE and CTO under Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981 based on self-certification of industries/project proponent.
