Office Order

Whereas power for deciding the applications for grant/refusal of consent to establish (CTE) and consent to operate (CTO) under Water (Prevention & Control of pollution) Act, 1974, Air (Prevention & Control of pollution) Act, 1981 and authorization under Hazardous Waste (MH&TM) Rules, 2008 were delegated to Regional Officers of the Board in their respective area of jurisdiction for Red and Orange category of industries/projects having an investment cost upto Rs. 10 crore or CLU cases upto 1 acre in conforming areas, vide Head Office order endst. No. HSPCB/139/2016/5814-5839 dated 02.03.2016, in view of provisions of Haryana Enterprises Promotion Policy, 2015 issued by Haryana Government, Industries & Commerce Department notified on 1st October 2015;

Whereas the Board, in its 175th meeting held on 04.05.2016 vide resolution no. 175.4, has accorded Ex-Post Facto approval regarding delegation of above said powers for grant/refusal of CTE and CTO under Water Act, 1974, Air Act, 1981 and to grant authorization under Hazardous Waste (MH&TM) Rules, 2008 to the Regional Officers of the Board;

Whereas the Hazardous Waste (MH&TM) Rules, 2008 has been superseded with Hazardous and other Wastes (Management and Transboundary Movement) Rules, 2016 by MoEF and CC vide notification no. G.S.R No. 395 (E). dated 04.04.2016; and

Whereas Board has issued order regarding re-categorization of industrial sectors under Red, Orange, Green and White categories vide Head Office order endst no. HSPCB/PLG/135/2016/546-572 dated 14.07.2016 in view of modified directions issued by CPCB vide letter dated 07.03.2016 wherein the Green category of industries/projects has also been covered under consent management, apart from Red and Orange category of industries/projects and white category of industries have been exempted from consent management and therefore there is need for delegation of power to Regional Officers of the Board, for grant/refusal of CTE and CTO under Water Act, 1974, Air Act, 1981 and authorization under Hazardous and other Wastes (Management and Transboundary Movement) Rules, 2016 in case of Green category of industries/projects also, having an investment cost upto Rs. 10 crore or CLU cases upto 1 acre in conforming areas.

In view of above, all Regional Officers of the Board are hereby delegated powers for grant/refusal of consent to establish and consent to operate under section 25/26 of the Water (Prevention & Control of pollution) Act, 1974 and under section 21 of the Air (Prevention & Control of pollution) Act, 1981, also for the Green category of industries/projects and authorization under Hazardous and other Wastes (Management and Transboundary Movement) Rules, 2016, in their respective areas of jurisdiction, having an investment cost upto Rs. 10 crore or CLU cases upto 1 acre in conforming area in addition to the powers already delegated to them for grant/refusal of CTE and CTO under the above said Acts, for Red and Orange category of industries/projects having same criteria, vide office order endst. No. HSPCB/139/2016/5814-5839 dated 02.03.2016.


