Office Order

Whereas the Board vide Head Office Order endst. No. HSPCB/PLG/2015/3735-3758 dated 20.10.2015 and Head Office order endst. No. HSPCB/PLG-142/2016/6228-6251 dated 22.03.2016 has laid down the procedure for grant and auto renewal of consent to operate (CTO) respectively under Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981 for red and orange category of industries wherein validity of CTO has been prescribed for 05 years in case of Red category and 10 years for orange category of industries/projects, in view of Haryana Enterprises Promotion Policy, 2015 issued by Haryana Government, Industries & Commerce Department notified on 1st October 2015;

Whereas the Board in its 175th meeting held on 04.05.2016, vide resolution no. 175.8 has accorded Ex-Post Facto approval of the above said procedure for auto renewal of consent to operate under Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981.

Whereas Board has issued order regarding re-categorization of industrial sectors under Red, Orange, Green and White categories vide order endst no. HSPCB/PLG/135/2016/546-572 dated 14.07.2016 in view of modified directions issued by CPCB vide letter dated 07.03.2016 wherein the Green category of industries/projects has also been covered under consent management, apart from Red and Orange category of industries/projects and white category of industries have been exempted from consent management;

Whereas the CPCB in its above said directions issued vide letter dated 07.03.2016 has also specified the period for grant of CTO to Green category of industries/projects for 15 years and therefore there is need to specify the period of CTO also for Green category of industries/projects according to the CPCB directions.

In view of above, it is hereby ordered that the validity period for grant and renewal of CTO for Green category of industries/projects shall be for 15 years.
