Proceedings of the meeting held on 13.10.2025 at District Secretariat Panipat regarding Yamuna Action Plan regarding Yamuna Action Plan.

List of participants is attached as Annexure.

Right at outset, the Deputy Commissioner, Panipat welcomed all the participants and briefed about the concern of Government regarding pollution in river Yamuna and requested MS HSPCB to permit for agenda of the meeting. MS HSPCB raised the concern of the Govt. regarding Yamuna pollution. He informed that the Union Home Secretary had convened a meeting on 17.09.2025 which was followed by a meeting under Chairmanship of Hon'ble Union Home Minister on 19.10.2025 and it was attended by Chief Secretary, Haryana.

The Union Govt. has given a mandate that the pollution level in drains should not be more the 10 mg/l in terms of Biochemical Oxygen Demand. So we have to work expeditiously in that direction. Further, Govt. has given mandate that a large scale anti pollution drive/activities be carried out by officers of District Administration and Pollution Control Board in coming 15 days. The objective is to make Yamuna pollution free upto maximum extent, So that Chhat Pooja festival be celebrated and faith of public be reverenced. The XEN HSVP not present and this matter was viewed seriously and it was decided to send a communication to CA, HSVP in this regard as he has not given priority to a matter of Yamuna Action Plan. Similarly, the representative of District Judge was also not present. The NGT has given a very strict mandate to SESTFs and it need to be complied in true letter and spirit.

There after MS, HSPCB asked JP Singh SEE to take up agenda one by one. Sh. J.P. Singh presented the agenda and the proceedings are given in coming paras.

- Industries bypass untreated effluent into storm water drain of Industrial Area which they claim to treat this effluent in CETP. It is worth to mention that storm water drains are for rain water and other effluent must not find entry into this drain. The Industries in industrial areas also use illegal/ banned fuel i.e. wood chips and every day the trucks of wood fuel enter in industrial area through multiple entries of industrial area and need to be monitored.
- II. Industries do not have solid waste management mechanism as a result there is littering in industrial area in many pockets on vacant plots, road sides etc. The Industries throw solid waste mixed with hazardous waste on empty plots and foot paths. It may be noted that industrial area management outside the premises of industries rest with HSVP.
- III. Industries using illegal/ banned fuel i.e. wood or wood chips. The HSIIDC officers were requested to bring such units in knowledge of HSPCB both at RO Head Office level
- IV. It was suggested that the industries should make agreement with WTE plant of Sonepat to dispose of solid waste.

V. It was further suggested that the foot paths should be cleared of grass/ weeds and the branches of trees over footpaths should be pruned for easy movement of the public.

After detailed discussion, various decisions were taken and these can be summarised as under:-

- 1. All the SDMs of the areas to monitor for the violations regarding illegal tankers and illegal fuel. The Tehsildar/Qanoogo/Patwaries/Police be deputed for this.
- The HSIIDC/HSVP should install check posts along CCTV cameras at all entries/exits of industrial areas of sonepat. They shall not allow entry of illegal tankers and illegal fuel.
- 3. The traffic police shall issue challan/impound illegal tankers which are not registered with MC and not allow disposal at any location other then STPs.
- 4. The Irrigation Department shall install fencing on all bridges for their drains and estimate for expenditure be sent to HSPCB for providing funds through EC funds. The drains inside the MC limit and which belong to MC shall also be fenced to prevent disposal of solid waste.
- The industries shall be directed to make agreement with WTE plant for disposal of solid waste from their premises.
- 6. The officers of HSIIDC are to find out the illegal connection made by industries into storm water drains and dismantle the same. This must be brought in knowledge of HSPCB RO as well as Head Office so that HSPCB could take deterrent and exemplary action. The layout maps of the storm water/sewerage network drains for all industrial areas be shared with HSPCB.
- 7. The drains in the village area has lot of solid waste dumped and such waste need to be disposed scientifically and further measures be taken to prevent such unscientific and unhygienic disposed of waste. The XEN Panchayati Raj was asked to send immediate steps taken or to be taken for next 7 days.RO Panipat was asked to obtain and send to HO, HSPCB.
- 8. The office of HSVP/HSIIDC were requested to report to HSPCB if any industry use illegal fuel such as wood, old cloths, plastic waste, etc.
- 9. It has already been decided in the meeting held at Sonepat. The ADC, Panipat informed that M/s JBW has not deployed adequate no. of vehicles and employees to lift waste to it WTE plant. The waste disposal is not adequate at Panipat inspite of having WTE facility. It has been decided in Sonepat that the solid waste from industries be disposed through W.T.E. plant. The industries need to make agreement with operator of WTE.
- 10. RO Panipat informed that the sewer pipeline are half blocked due to settling of sludge inside pipes and accordingly, the capacity of sewers have reduced. It causes leakage at various places in the industrial areas. After discussion, the DC

- Panipat directed that the sewers of industrial area be cleaned and there should not be leakage at any time in any place of the industrial area. It is also a violation of the provisions of the Water Act.
- 11. The police need to place check posts at various places where the tankers carrying septage and industrial effluent can be discharged into drains/roadsides or any other place. Such tankers carrying industrial/septage be made to carry the same to STP/CETP for disposal. The vehicles need to be impounded and the source of such liquid need to be identified/informed to HSPCB, in case the effluent in tanker belong to any industry. Such industries are to be closed immediately. RO was asked to obtain the list of all such police check posts along GEO coordinates.
- 12. The XEN/SDE/JE be deputed in shifts to monitor the operation of STPs round the clock for next 15 days and there should not be any breakdown in the operation of STPs.

Meeting ended with thanks to all participants and the chair.
